BridgePrep has elected to also use SAT10 on March 21<sup>st</sup> and 22<sup>nd</sup> to compare performance evaluation and assist with course placement for the upcoming school year. SAT's will provide us multiple sources of data. Additionally, any student who is "identified" as requiring testing accommodations with a 504 or IEP will be provided those adaptations as needed and allowable. In June, your child will receive an Individual Student Report that provides information about how he or she is progressing academically. This can be picked up in our offices over the summer months.

Please review the following policies with your child before testing:

- Electronic Devices—if your student is found with ANY electronic devices, including, but not limited to, cell phones and smart phones, at any time during testing OR during breaks, his or her test section will be invalidated, which means it will not be scored. It's best to leave devices at home or in locker.
- Leaving Campus—if your student leaves campus before completing a test section (for an appointment, illness, etc.), he or she WILL NOT be allowed to complete that test section. Arriving on time and leaving during dismissal will be key.
